#### **ORDER:**

During the Budget Session 2014-2015, the Hon'ble Chief Minister has inter-alia made the following announcement on 24.7.2014 under Rule 110 of Tamil Nadu Assembly Rules, pertaining to State Industries Promotion Corporation of Tamil Nadu Limited (SIPCOT).

Steps will be taken to increase the Ground Water in the Water bodies in three Industrial Complexes/Parks which are under the control of SIPCOT at a cost of Rs.6 crores (Rupees six crores) and 42 Oxidation Ponds in SIPCOT Industrial Complexes will be revamped at an expenses of Rs.40 lakhs each. Initially, 10 (Ten) Oxidation Ponds will be taken up for revamping at a total expense of Rs.4 Crores for this current year.

2. In view of the importance to implement the above scheme announced by the Hon'ble Chief Minister, in time, the Government after careful consideration accord in-principle approval to the Managing Director, SIPCOT to implement the above announcement expeditiously.



3. The Managing Director, SIPCOT is also directed to send necessary proposal where necessary, to Government for formal approval with all relevant details along with the recommendations of the Board of SIPCOT in due course.


