The FinTech Governing Council will form sub-committees to address various themes in the upcoming FinTech Policy such as marketing and branding, business development and outreach, partnerships, education, venture capital and regulation. The FinTech Governing Council will also enlist the support of experts, specialist institutions in each of these areas, as and when required.
- 4. Additional representation from Government/industry/academia shall be included in the FinTech Governing Council as per the progress and requirement of activities to be undertaken.
- 5. The Managing Director and Chief Executive Officer, Guidance Tamil Nadu will be the Member Convener of the Council. The Council shall meet once in six months.
