ORDER:

In the Government Order first read above the Government have accorded Administrative approval and Financial sanction for a sum of Rs.6,25,00,000/- annually to Electronics Corporation of Tamil Nadu Limited (ELCOT) for conducting the "UMAGINE" event. Accordingly, the maiden UMAGINE event was conducted in Chennai Trade Centre from 23rd to 25th March 2023.

2. In the letter 2nd read above, the Managing Director, Electronics Corporation of Tamil Nadu Limited has stated that Electronics Corporation of Tamil Nadu Limited had successfully conducted the "UMAGINE-2023" event in March 2023 along with M/s. Confederation of Indian Industry (CII) as Event Partner. The entire Event, which is the first of its kind in the State for IT Sector, went on well and it was a grand success with approximately 18,000 registrations. It also had a thematic session under seven verticals with 120 sessions by over 320 speakers including 60 international speakers. The total foot fall for the event was around 50,000 and the exhibition was also a grand one, showcasing the success of the State in IT Sector.

3. He has also stated that, this tech showcase featured an array of innovative products, services and solutions from leading companies and startups in various sectors. Attendees had the chance to witness first-hand how the latest advancements in technology are transforming industries and shaping the future, enabling them to gain valuable insights and inspiration for their own organisations and initiatives.

4. The Managing Director, Electronics Corporation of Tamil Nadu Limited has further stated that as the UMAGINE Chennai, is an Annual Tech Summit, it has been proposed that "UMAGINE Chennai 2024" event will be conducted at Chennai during February 2024. He has therefore requested the Government to sanction and release an amount of Rs.6,25,00,000/- (Rupees Six Crore and Twenty Five Lakh only) to Electronics Corporation of Tamil Nadu Limited towards conducting UMAGINE Chennai 2024 event.

5. The Government, after careful examination of the above, hereby accord financial sanction and release a sum of Rs.6,25,00,000/- (Rupees Six crore and Twenty Five lakh only) to Electronics Corporation of Tamil Nadu Limited for organizing the UMAGINE event in Chennai during February, 2024. The Managing Director, Electronics Corporation of Tamil Nadu Limited is authorized to settle the claims for conducting the event based on the submission of bills / expenditure statement.

6. The expenditure sanctioned in paragraph 5 above shall be debited to the following Head of account:

"2852 – Industries – 07- Telecommunication and Electronic Industries – 800 Other expenditure – State's Expenditure – JC–Grants to ELCOT towards promotion of Information Technology - 309 – Grants-in-Aid – 01 Grants for Current Expenditure.

7. Necessary additional funds of Rs.6,25,00,000/- (Rupees Six crore and Twenty Five lakh only) will be provided in FMA 2023-2024 to meet the expenditure sanctioned in paragraph 5 above. However, this expenditure shall be brought for the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2023 - 2024. Pending provision of such funds, the Section Officer, Information Technology and Digital Services (Bills) Department is authorized to draw and disburse the amount sanctioned in paragraph 5 above to Electronics Corporation of Tamil Nadu Limited through Electronic Clearing System (ECS). The Under Secretary to Government, Information Technology and Digital Services Department is directed to include this item of expenditure while sending the budget proposal for FMA 2023-2024 and also send necessary draft explanatory note for inclusion of this expenditure in the supplementary Estimate 2023-2024 to Government in Finance (Industries/BG-I) Department at the appropriate time without fail.

The Managing Director, Electronics Corporation of Tamil Nadu Limited is directed to send the utilization certificate and usefulness report to the Additional Chief Secretary to Government, Information Technology and Digital Services Department after conducting the event. He is also directed to remit the unspent balance amount if any into the Government account.
