ORDER:

In the Government Order first read above, Government had issued orders on the system of purchase preference to be followed while making purchases by Government Departments/Public Sector Undertakings / Boards / Local Authority / Co-operative Institutions.

2. In the Government Order second read above Government nominated Electronics Corporation of Tamil Nadu Limited (ELCOT) as an optional procurement Agency for the purpose of procuring Information Technology Hardware and Software products by Government Departments/State Public Sector Undertakings/State Autonomous Bodies/ Boards/Local Authority/Co-operative Institutions.

3. In the letter third read above, the Commissioner of e-Governance/Chief Executive Officer, Tamil Nadu e-Governance Agency requested the Government to issue orders appointing Tamil Nadu e-Governance Agency as optional procurement Agency under Section 3(3) of the Tamil Nadu Transparency in Tenders Act, 1998 for providing the Information Technology Services and consultancies to the Government Departments/ Agencies/ Statutory bodies / State Public Sector undertakings and State Autonomous bodies.

4. The Government after careful examination of the proposal of Commissioner of e-Governance/Chief Executive Officer, Tamil Nadu e-Governance Agency decided to accept the same and hereby nominate Tamil Nadu e-Governance Agency as an optional procurement Agency for the following Information Technology Services and consultancies to Government Departments/Agencies/Statutory Bodies/State Public Sector Undertakings/State Autonomous Bodies.

1. Software development & implementation/ System integration.
2. Software maintenance and support.
3. Software testing.
4. Information Technology (IT) security audit services.
5. Data services (processing, migration).
6. Skilled Information Technology manpower deployment.
7. Online exam service.
8. Help desk for Information Technology services.
9. Information Technology infra services onsite/ offsite (excluding hardware procurement).
10. Data centre maintenance.
11. Aadhar Authentication services.
12. Digital content development & maintenance.
13. Geographical Information System services.
14. Information Technology / e-Governance Capacity building (training) services.
15. Information Technology consulting.
16. Network maintenance services.
17. Information Technology procurement services (excluding hardware procurement).

5. The Government Departments/ Agencies/ Statutory bodies / State Public Sector undertakings and State Autonomous bodies shall have choice of engaging/hiring on their own or seek the assistance of Tamil Nadu e-Governance Agency for the Information Technology services and consultancies, even while utilizing the services of Tamil Nadu e-Governance Agency as an optional procurement Agency. Tamil Nadu e-Governance Agency will have to abide by all the guidelines issued by the Government from time to time and in force for the procurement of Information Technology products and tender procedures.

6. Necessary notification under sub-section (3) of Section 3 of the Tamil Nadu Transparency in Tenders Act, 1998 will be issued separately by Finance (Salaries) Department.

7. This order issues with the concurrence of Finance (Sal) Department vide its U.O. 34580/Fin(Sal)/2019, dated 24.7.2019.
