ORDER:

During the Governor's Address on the floor of the Tamil Nadu Legislative Assembly, the Honourable Governor of Tamil Nadu on 21.06.2021, among-other things, has made the following announcement:-

"This Government will make all efforts to ensure transparency and accountability by promoting e-Governance and providing substantially enhanced access to Government services through the online mode. Online open access from anywhere will be enabled to ensure that "Any Time Any Place Services" are made available".

2. The Commissioner of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency, in his letter read above, has stated that Whole-of-Government approach to Digital transformation aimed at offering of services in 'Anytime, Anywhere' model to Citizens and thereby make their lives easier. This entails large scale Digital transformation of Government processes and procedures, migration of paper based file processing to e-Office, creation of e-Dashboards and Decision Support Systems for increased efficiency etc., and requires systematic and continued interactions with Government Departments at all levels.

The Commissioner of e-Governance & Chief Executive Officer, TNeGA, in the letter read above, has requested that a senior person having administrative experience of handling various Departments of Government at senior level (including Information Technology) may be appointed as an Advisor (Digital and Simplified Governance) to Tamil Nadu e-Governance Agency with appropriate remuneration as deemed fit by Government.

4. The Government, after careful examination of the above proposal, hereby appoints Thiru P.W.C.Davidar, I.A.S.(Retd.), as Advisor (Digital and Simplified

Governance) to Tamil Nadu e-Governance Agency. The above position is purely honorary without any remuneration. However, the Officer will be entitled to Office Space, Attendant Staff, Vehicle, Telephone and TA/DA facility as admissible to Additional Chief Secretary and the expenditure thereof will be met out by TNeGA from its own funds.
