ORDER:

In the Government order 1st read above, orders have been issued directing the Revenue Department to look after the Crisis Management Plans (CMPs) / Standard Operating Procedures (SOPs) responding to:

- a. Aftermath of a nuclear attack
- b. Terrorist attacks using radioactive materials
- c. Terrorist attacks using Chemical Weapons
- d. Terrorist attacks using Biological Agents
- e. Countering Cyber Terrorism
- 2. In the letter 2nd read above, it has been stated that the Revenue department would be assisted by the Principal Secretary to Government, Information Technology Department in the finalization of CMP/SOP for countering Cyber Terrorism.
- 3. In the meeting held on 1.6.2016 to discuss the issues relating to Cyber Security, ELCOT was directed to send necessary proposals for the formation of a State Level Security Governance Committee. Accordingly, in the letter 4th read above the Managing Director, ELCOT has sent a proposal for the formation of a Security Governance Committee (SGC). He has further informed that SGC will assist in forming the Computer Emergency Response Team for Tamil Nadu (CERT-TN) and give necessary guidance to CERT-TN as and when required.

4. The Government after careful examination decided to accept the above proposal and hereby constitute two Committees namely a High Level Security Governance Committee (SGC) and a Technical Committee for Security Governance with the following composition:-
