ORDER:

In the Government Order first read above, orders were issued for implementing e-Office in all Government departments/ PSUs/ Boards/ Agencies of the Government of Tamil Nadu.

In the Government order second read above, administrative approval and financial sanction were accorded for implementing e-Office in the Heads of Departments and Subordinate Offices at an estimated cost of Rs.7.06 crore from the own funds of Tamil Nadu e-Governance Agency under Phase I of the Project.

3. In the letter third read above, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency has stated that for the effective implementation of e-Office in Directorates/ Commissionerates, augmenting their user infrastructure is very much essential. In this regard, the DeG/CEO, TNeGA has furnished the Head office user-infra requirements given by 79 Directorates (till 29.10.2022).
