From the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency, Letter No.H-05/1/17-cons-Proc (TNeGA), dated 18.07.2023.

ORDER:

In the letter read above, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) has stated that M/s. SoftTech Engineers Private Limited was selected as the L1 bidder and an agreement was signed with M/s.SoftTech Engineers Private Limited as the System Integrator to develop and maintain the Chennai Metropolitan Development Authority (CMDA) Online plan permission approvals application on 06.12.2017 for a value of Rs.1.65 crore inclusive of GST. As per contract signed between TNeGA and M/s Softech Engineers Private Limited dated 06.12.2017, the contract period is 6 years+11 months and work order was issued on 15.12.2017. The application was partially launched on 06.12.2018. Subsequently, the Completion Certificate module was completed and made Live on 01.10.2019.

2. The Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency has further stated that M/s. Softech has submitted a Change request proposal for the additional work due to the change in rules stating that they would complete the additional modules and change requirements upon approval of change request work order. M/s SoftTech Private Limited was paid towards the deployment of two additional onsite software support manpower for the period from 01.01.2019 to 31.12.2021 based on the approval provided by CMDA. The maximum change request provision of 25% of the contract value as per the Tamil Nadu Transparency in Tenders Act has already been utilized and there is no more provision for the additional modules and change requirements requested by CMDA.

3. The Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency has requested the Government to accord approval for implementation of additional modules and change requirements through the existing System Integrator viz. M/s Softech Engineers Private Limited

by invoking clause (b) section 16 of Tamil Nadu Transparency in Tenders Act 1998 for implementing web based single window system for online Plan Permission Approvals (PPA) in CMDA.

4. The Government after careful examination of the proposal of the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency hereby accord approval to TNeGA for implementation of additional modules and change requirement through the existing System Integrator viz. M/s Softtech Engineers Private Limited by invoking clause (b) under section 16 of Tamil Nadu Transparency in Tenders Act, 1998 for implementing web based single window system for online Plan Permission Approvals (PPA) in CMDA.
