### ORDER:

The Hon'ble Chief Minister of Tamil Nadu, in his reply to His Excellency, Governor's address in the Legislative Assembly, has announced to establish a Centre of Excellence on the Emerging Technologies (CEET) viz., Artificial Intelligence & Machine Learning (Al&ML), Blockchain, Internet of Things (IoT), Drones and Data Analytics in Tamil Nadu.

2. In the Government order 1<sup>st</sup> read above, the Government have accorded Administrative Sanction and Financial Sanction for setting up of Centre of Excellence in Emerging Technologies (CEET) at an estimated cost of Rs.8 Crore (Rupees eight crore only) for first year operation, as detailed below:-

In the letter 2<sup>nd</sup> read above, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) has requested the Government to sanction a sum of Rs.5,19,27,982/-(Rupees five crore nineteen lakh twenty seven thousand nine hundred and eighty two only) towards second year operation of Centre of Excellence in Emerging Technologies for the financial year 2021-22.

The Government after careful examination of the proposal of the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency hereby accord financial sanction for the 2<sup>nd</sup> year operation of Centre of Excellence in Emerging Technologies at an estimated cost of the Rs.3,73,03,905/- (Rupees three crore seventy three lakh three thousand nine hundred and five only) as detailed below and order the continuance of the project for only two more years.
