### **ORDER:**

In the reference 1<sup>st</sup> read above, the Finance (Ways & Means) Department has requested to furnish schemes earmarked for getting assistance from Government of India under Part-V of the “Scheme for Special Assistance to States for Capital Investment for 2022-23” for the year 2022-23.

2. In the reference 2<sup>nd</sup> read above, the Managing Director, TANFINET has sent a proposal for “BharatNet Last Mile Connectivity” at an outlay of Rs. 323.42 Crore to be implemented with funds from Government of India under Part-V of the “Scheme for Special Assistance to States for Capital Investment for 2022-23” for the year 2022-23.

3. In the reference 3<sup>rd</sup> read above, the Public Finance States Division, Department of Expenditure, Ministry of Finance, Government of India has sanctioned an amount of

Rs.184.00 Crore for the State of Tamil Nadu for implementing the BharatNet Last Mile Connectivity project to be implemented under Part-V of the "Scheme for Special Assistance to States for Capital Investment for 2022-23" for the year 2022-23.

In the reference 4<sup>th</sup> read above, the Government of India released financial sanction of Rs.184 Crore to Government of Tamil Nadu and requested to release the same to the Implementing Agency, i.e. M/s.TANFINET Corporation within 10 working days subject to the Condition that "the amount released shall be utilised by 31.03.2023".

5. In the reference 5<sup>th</sup> read above, the Managing Director, TANFINET Corporation was requested to send necessary revised proposal for the sanctioned amount of Rs.184.00 crore along with Detailed Project Report to enable release of funds within 10 working days.

In the reference 6<sup>th</sup> read above, due to time constraint in releasing and utilising of funds, orders were issued for release of funds of Rs.184.00 Crore received from Public Finance States Division, Department of Expenditure, Ministry of Finance, Government of India to Tamil Nadu FibreNet Corporation Limited (TANFINET).

In the reference 7<sup>th</sup> read above, the Managing Director, TANFINET Corporation has sent a revised proposal to Government along with the Detailed Project Report (DPR) for implementing the BharatNet Last Mile Connectivity project within the sanctioned and released amount of Rs. 184.00 Crore as below:
