### **ORDER:**

In the Government Order 1<sup>st</sup> read above, the Tamil Nadu e-Governance Agency was formed with a Governing Board and an Executive Committee comprising the following:

The Tamil Nadu e-Governance Agency has been registered as a Society with the following as members in the Governing Board.

As per existing bye-law 19(1) of the Tamil Nadu e-Governance Agency, the Governing Board shall consist of a minimum of three members and a maximum of seven members.

2. In view of the above, the Chief Executive Officer, TNeGA, has in the references 2<sup>nd</sup> and 3<sup>rd</sup> read above, requested the Government for an amendment to bye-laws 19(1) and 19(3) of the Tamil Nadu e-Governance Agency. He has also requested to strengthen the Governing Board by increasing the number of members in the Governing Board to 14 from the present 7 and also by increasing the prescribed quorum for meetings of the Governing Board to FIVE from the existing THREE. Further, he has requested to include the Secretaries of the eleven Mission Mode Departments as Members in the present Governing Board of Tamil Nadu e-Governance Agency in addition to the existing members.

3. The Government after careful examination of the above proposal of Tamil Nadu e-Governance Agency, have decided to accept and accord approval for amendment to the Bye-law 19(1) to increase the maximum Number of Members in Governing Board as FOURTEEN Members from the existing SEVEN Members and to Bye law 19(3) to increase the prescribed quorum for meetings of the Governing Board to FIVE from the existing THREE and also to include the Secretaries of the following Mission Mode Departments as Members in the Governing Board of Tamil Nadu e-Governance Agency in addition to the existing three members mentioned at paragraph 1 above.

Municipal Administration and Water Supply Department.
- x) Secretary to Government,  
Co-operation, Food & Consumer Protection Department
- xi) Principal Secretary to Government,  
School Education Department
