- 3. In Government Order fifth read above, an amendment to the Government Order second read above was issued so that the Directorate of e-Governance and the Tamil Nadu e-Governance Agency would co-exist.
- 4. During the Budget session 2013-14, on 08.05.2013, the Hon'ble Chief Minister made a statement on the floor of Legislative Assembly under 'Rule 110 of the Tamil Nadu Legislative Assembly Rules' that the Directorate of e-Governance originally formed for implementation of the e-Governance initiatives in Government departments, needs to be strengthened and hence, it is proposed to create an "Information Technology Cadre" with personnel skilled and trained in Computer Technology, under the control of the Directorate of e-Governance.
- 5. Accordingly, in the letters fourth and sixth read above, the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency has sent a detailed proposal for 'Creation of an Information Technology Cadre' as detailed below under the control of the Directorate of e-Governance at an annual recurring cost of Rs.7,76,27,580/-(Rupees seven crores seventy six lakhs twenty seven thousand five hundred and eighty only) so as to implement the e-Governance initiatives more effectively in the State and also for providing better services to citizens:

The Government after careful examination have decided to accept the above proposal of the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency and accord sanction for 'Creation of an Information Technology Cadre' comprising the following posts under the control of the Directorate of e-Governance, as detailed below:

- 7. The Commissioner of e-Governance is directed to Categorize and Classify the above posts as Information Technology Service & Information Technology Subordinate Service as per orders in force so as to rationalize the entire Information Technology Cadre in Government departments and also formulate the Service Rules (Special/Ad-hoc Rules) for these posts and send a separate proposal to Government at the earliest for approval. The Commissioner of e-Governance is also directed to take necessary action to fill up the posts at the earliest.
- 8. The expenditure for the above sanctioned posts shall be debitable under the following head of account:
 - "2220-Information and Publicity-60. Others-001. Direction and Administration-I. Non-Plan-AB. Directorate of e-Governance-01. Salaries (DPC 2220 60 001 AB 0102)".
- 9. The expenditure sanctioned in para 6 above shall constitute an item of "New instrument of Service" and the approval of the legislature will be obtained in due course. Pending approval of the legislature, the expenditure will initially be met from the contingency fund, for which orders will be issued from Finance (BG-I) Department. The Deputy Secretary to Government, Information Technology Department is directed to send necessary proposals in the prescribed format to

Finance (BG-I) Department for drawal of Advance from contingency fund. The Deputy Secretary to Government, Information Technology Department / Director of e-Governance is also directed to send a draft explanatory note, indicating the total cost of the scheme, the funds that would be required for the implementation during the Financial year etc., to Government in Finance (BG-I) Department for inclusion of the expenditure in the Supplementary Estimates, for bringing it to the notice of the legislature in due course.
