ORDER:

"Capacity Building" is one of the Mission Mode Project (MMP), with the objective to provide professional resources and training support to political and policy level decision makers. Capacity Building and Knowledge Management programmes have to be done for wide variety of e-Governance Training programmes targeted at different levels in State Government Departments.

2. In the letter first read above, the Government of India has specified a total outlay of Rs.3.34 crore towards Capacity Building program for the State of Tamil Nadu and has requested confirmation, for continuation of the scheme and arrangement of 50% State Share, i.e. Rs.1.67 Crore from State Government budget.

- 3. In the letter 2nd read above, the Government of Tamil Nadu has conveyed its concurrence to the proposal of Government of India for continuation of the scheme of Capacity Building Phase II under NeGAP with the revised funding pattern of 50:50 by the State and the Centre.
- 4. In the Government orders 3rd and 4th read above, an amount of Rs.30,71,883/and Rs.20,74,217/- have been released towards State share for Capacity Building Phase II project.
- 5. In the reference 5th read above, National e-Governance Division (NeGD), Ministry of Electronics and Information Technology (MeitY), Government of India has released the fourth installment for a sum of Rs.5,00,000/- towards the Centre's share for Capacity Building Phase II project.
- 6. In the reference 6th read above, the Commissioner of e-Governance/Chief Executive Officer, Tamil Nadu-Governance Agency, has sent a proposal to Government towards release of State and Central share for Capacity Building Phase-II project as tabulated below:

- 7. So far, out of Rs.1.67 crore towards Central share, a sum of Rs.56,46,100/-has been released by MeitY, Government of India and out of Rs.1.67 crore towards State share, a sum of Rs.51,46,100/- has already been released by the State Government. Now, the Commissioner of e-Governance / Chief Executive Officer, TNeGA has requested the Government to release the balance amount of Rs.1,15,53,900/- towards State share to implement the Capacity Building Phase II project and has also requested MeitY, Government of India to release an amount of Rs.1,10,53,900/- towards Government of India Share to implement Capacity Building Phase II project in the State.
- 8. The Government after careful examination of the above proposal of Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency, hereby accord Financial Sanction and release an amount of Rs.5,00,000/-(Rupees five lakh only) to Tamil Nadu e-Governance Agency towards third State share which is equivalent to the 4th installment released by Ministry of Electronics and Information Technology, Government of India for Capacity Building Phase II project.
- 9. The expenditure sanctioned in paragraph 8 above shall be debited to the following Head of Account:-

"2852.INDUSTRIES – 07. Telecommunication and Electronic Industries-800. Other Expenditure – Schemes shared between State and Central – UA Assistance towards State Data Centre / Tamil Nadu Wide Area Network / National e-Governance Action Plan (NeGAP) – 309 Grants -in-Aid – 03 Grants for Specific Schemes"

- 10. Necessary additional funds of Rs. 5,00,000/- will be provided in RE/FMA 2021-2022. Pending provision of such funds, the Section Officer (Bills), Information Technology Department is authorized to draw and disburse the amount sanctioned in paragraph 8 above, if it is found to be in order. The Section Officer (Bills), Information Technology Department shall include this item of expenditure while sending the Budget proposal for RE/FMA 2021-2022 to Government in Finance (Industries) Department at the appropriate time without fail.
- 11. The Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) is requested to send the physical and financial progress of the scheme every month to the Government along with the details of expenditure incurred and Utilization Certificate. Unspent balance, if any, should be remitted into Government account.

12. This order issues with the concurrence of Finance (Industries) Department vide its U.O. No. 46164/Fin(Ind)/2021, dated 28.10.2021 and Additional Sanction Ledger No. 710 (seven hundred and ten).
