#### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Employment and Training Subordinate Service (Section 7B of the Tamil Nadu Service Manual Volume-III).

## **AMENDMENT**

In the said Special Rules, in rule 2, in the tabular column under sub-rule (a), under the heading "CLASS-I", in column (2), against the Category "(1) Training Officers in the Industrial Training Institutes / Centres." in column (1) thereof, for item (ii) and the entries relating thereto, the following shall be substituted, namely:-

- "(ii) Promotion in the ratio of 1:1 as between,-
  - (a) Degree / Diploma holders; and
  - (b) Certificate holders with S.S.L.C. and five years service as Assistant Training Officers;.

Provided if no degree/diploma holder or certificate holder is available for promotion as per the term in the cyclical order, that vacancy shall be filled by a person having the qualifications mentioned in the next turn in the cycle;".
