ORDER:-

The Director of Legal Metrology, Ministry of Consumer Affairs, Food and Public Distribution, New Delhi in the reference 1st read above has stated that the transaction of milk may be done in unit of volume and however if done in mass especially for bulk transaction, the volume is also to be mentioned, as done in case of edible oils. It has also stated that the non-automatic weighing instruments (electronic balances) may be used to weigh the mass of the milk, which may be converted into volume mathematically, using the specific gravity of milk being transacted.

- 2. Based on the instruction of the Government of India, the Commissioner of Labour in the letter second read above has sent proposal to issue necessary amendment to the schedule I to the Tamil Nadu Legal Metrology (Enforcement) Rules, 2011.
- 3. The Government, after careful examination, have decided to accept the proposal of Commissioner of Labour to amend the schedule I referred to in rule 10 of the Tamil Nadu Legal Metrology (Enforcement) Rules, 2011.
- 4. The appended Notification shall be published in the <u>Tamil Nadu Government</u> <u>Gazette</u> both in English and Tamil.
- 5. The Director, Tamil Development and Information (Translation) Department, Secretariat, Chennai 600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai-600 001.

6. The Works Manager, Government Central Press, Chennai - 600 001 is requested to publish the gazette Notification and send fifteen copies of the Gazette Notification to the Government for reference and record.
