### ORDER:

During the 2014-2015 Budget session of the Tamil Nadu Legislative Assembly, Hon'ble Chief Minister has made a statement on 12.8.2014 under rule 110 of the Tamil Nadu Legislative Assembly rules, wherein among other things it was announced that the migrant construction workers shall be registered in Tamil Nadu Construction Workers Welfare Board based on the employer certificate along with other certificates produced by them.

2. Accordingly, in the letters read above, the Commissioner of Labour has sent proposals for registering migrant construction workers in Tamil Nadu Construction Workers Welfare Board.

3. After careful consideration the Government issue orders to register the migrant manual workers engaged in construction work, as defined in clause 2(c) of Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994, read with section 2(10) of Tamil Nadu Manual Workers (Regulation of Employment and

Conditions or Work) Act, 1982, in the Tamil Nadu Construction Workers Welfare Board. Guidelines in this regard will be issued separately.
