ORDER:

In the Government order first read above (out of the Budget Estimate provisions of Rs.149,81,74,000/-) a sum of Rs.36,99,10,500/- (Rs.33,60,43,500/- + Rs.3,35,57,500/- + Rs.3,09,500/-) had been sanctioned as grants for the financial year 2019-2020 under General Category, Special Component Plan for Scheduled Castes (SCSP) and Tribal Area Sub Plan (TSP) to Tamil Nadu Manual Workers Social Security and Welfare Board and 14 Other Welfare Boards.

2. In the Government order second read above, a sum of Rs.77,28,29,000/- was released as grants for the second quarter of the financial year 2019-2020 under General Category.

3. In the letter third read above, the Commissioner of Labour has sent proposal to release a sum of Rs.2,02,51,500/-(Rs.1,99,14,000/- + Rs.3,37,500/-) under Special Component Plan for Scheduled Castes (SCSP) and Tribal Area Sub Plan (TSP) Categories as the second quarter grant for the financial year 2019-2020.

4. The Government after careful consideration, release a sum of Rs.2,02,51,500/-(Rupees two crores two lakhs fifty one thousand and five hundred only) as grants for the second quarter of the financial year 2019-2020 under Special Component Plan for Scheduled Castes (SCSP) and Tribal Area Sub Plan (TSP) Categories to Tamil Nadu Manual Workers Social Security and Welfare Board and 14 Other Welfare Boards.
