Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Registrar General, High Court is requested to calculate the actual amount required for the period up to next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Registrar General, High Court is also requested to send necessary explanatory notes to the Government in Finance (Home II) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2018-2019, at the appropriate time without fail.
- 6. The incumbents of newly created posts at para 3 above are eligible to draw pay and other allowances as per orders in force.
