ORDER:-

In the letter read above, the Commissioner of Labour has sent a proposal requesting for sanction of Grant for a sum of Rs.72,40,00,000/- under General Category by giving exemption of quarterly control of appropriation, Rs.3,41,21,500/- under SCSP Category and Rs.12,01,000/- under TSP Category for the 1st quarter to the Tamil Nadu Manual Workers Social Security and Welfare Board and 14 Other Welfare Boards, allotted in the Budget Estimate for the Financial Year 2018-2019.

2. The Government, after careful consideration release a sum of Rs.59,85,00,000/- (Rupees fifty nine crores and eighty five lakhs only) as grants for the Financial Year 2018-2019 out of the Budget Estimate provisions of Rs.87.80 crores to Tamil Nadu Manual Workers Social Security and Welfare Board and 14 Other Welfare Boards for providing Financial Assistance and Administrative expense by relaxing quarterly control of appropriation system in respect of General Category for which orders issued in G.O.(Ms.)No.114, Finance (BG-I) Department, dated 28.3.2018.
