He has requested the Government to sanction a sum of Rs.10,00,00,000/- (Rupees Ten Crore only) as Grant for meeting the current expenditure.

5. The Director of Legal Studies, Chennai, is authorized to draw and disburse the amount to the Tamil Nadu Dr.Ambedkar Law University, Chennai.
