# ORDER:

In the Order first and second cited, Hon'ble High Court of Madras has *inter-alia* directed the Government to appoint an expert committee to monitor the recruitment process of the posts of Assistant Professors and Assistant Professors (Pre-Law) of the Government Law Colleges under the Chairmanship of Hon'ble Justice Thiru N.Paul Vasanthakumar, Retired Chief Justice, High Court of Jammu&Kashmir and instructed the Committee to place the status report before the Court during the first week of July, 2018 apprising the stage of recruitment process.

2. Pursuant to the aforesaid orders of High Court, the Director of Legal Studies in the letter third cited has submitted a proposal to the Government and has requested to issue necessary orders constituting a committee to monitor the entire recruitment process of 186 posts of Assistant Professor and Assistant Professor (Pre-Law) of the Government Law Colleges.

3. The Government after careful consideration have decided to accept the request of Director of Legal Studies and accordingly constitute the following Expert Committee to monitor the entire recruitment process of 186 posts of Assistant Professor and Assistant Professor (Pre-Law) of the Government Law Colleges:-

4. The aforesaid Committee shall,-

(i) monitor the entire process of selection for 186 posts of Assistant Professor/Assistant Professor (Pre-Law) in Government Law Colleges in Tamil Nadu;

(ii) issue necessary instructions and guidelines to the Teachers Recruitment Board to finalise and issue a notification for recruitment so as to ensure that the notification is free from any litigation;

(iii) decide the modalities of setting question papers, conducting written examination and interviews;

(iv) issue instructions and guidelines to the Teachers' Recruitment Board to finalise question paper setters and examiners for valuation of the examination papers;

(v) constitute interview boards, as per University Grants Commission norms, for conducting interviews.

5. The Director of Legal Studies shall, on behalf of the Committee, file the status report before the Hon'ble High Court during the first week of July, 2018 apprising the stage of recruitment process.

6. The Chairman, Teachers Recruitment Board is requested to make necessary arrangements for the meetings of the Committee and also offer necessary assistance to the Expert Committee in discharging its functions.

7. The meetings of the Expert Committee will be held at the premises of the Tamil Nadu Dr.Ambedkar Law University, No.5, Dr. D.G.S. Dinakaran Salai, Poompozhil, Raja Annamalaipuram, Chennai – 28 or at such other place as the Chairman of the Committee may decide. The Registrar(i/c), Tamil Nadu Dr.Ambedkar Law University shall make necessary arrangements for the smooth conduct of the meeting whenever the meeting is convened in the aforesaid premises.
