#### ORDER:

As per the recommendation of Justice P.Shanmugam Commission of Inquiry and pursuant to the directions of Hon'ble High Court of Madras orders were issued according administrative and financial sanction in the Government Orders 1st and 2nd read above for the construction of two new Government Law Colleges at Kancheepuram and Thiruvallur districts for shifting Dr.Ambedkar Government Law College, Chennai.

- 2. In the order 3<sup>rd</sup> read above, Hon'ble High Court of Madras *inter-alia* has ordered that there shall not be any conduct of classes in Dr.Ambedkar Government Law College, Chennai, from 1<sup>st</sup> May, 2018 onwards except the conduct of examinations and the entire process of shifting shall be completed soon and the class should be commenced in the new colleges from 09.07.2018 for the academic year 2018-2019.
- 3. In the letter 4<sup>th</sup> read above the Director of Legal Studies has stated that the construction works of Government Law Colleges at Pudupakkam in Kancheepuram district and Pattarai Perumpudur in Thiruvallur district were completed. He has also stated that as per the orders of High Court of Madras, Dr.Ambedkar Government Law College, Chennai should be shifted to the newly constructed campuses at Pudupakkam in Kancheepuram district and Pattarai Perumpudur in Thiruvallur district before the commencement of the next academic year on 9<sup>th</sup> July, 2018, and he has requested the Government to issue necessary orders to shift Dr.Ambedkar

- 4. The Government after careful consideration of the request of the Director of Legal Studies have decided to shift the Dr.Ambedkar Government Law College, Chennai from its present premises to newly constructed campus at Pudupakkam in Kancheepuram district and Pattarai Perumpudur in Thiruvallur district and to conduct the 5 year Law course in the newly constructed campus at Pudupakkam in Kancheepuram district and to conduct the 3 year Law course and L.L.M courses in the newly constructed campus at Pattarai Perumpudur in Thiruvallur District from the academic year 2018-2019 and orders accordingly.
- 5. The Director of Legal Studies is requested to carry out the shifting work in an expeditious manner in coordination with Public Works Department and to deploy the existing teaching and non-teaching staff of Dr. Ambedkar Government Law College, Chennai to the aforesaid two colleges.
- 6. The Director of Legal Studies is requested to ensure that appropriate police protection is provided in both the Government Law Colleges and necessary transport facilities are made to the students of both the Law Colleges in coordination with the concerned Police officials and Transport department officials.
