#### ORDER:

In the Government Order eighth read above, among other things, orders were issued implementing the revised University Grants Commission scales of pay to the teachers/librarians working in the Government Colleges and Universities with notional effect from 01.01.2006. In the above said Government order, it has also been ordered that there shall be only three designations in respect of teachers in Universities and Colleges, namely, Assistant Professor, Associate Professors and Professors. In the Government order ninth read above, the above orders were extended to the posts in Government Law Colleges also. Accordingly, the Government have decided to amend the Special Rules for the Tamil Nadu Legal Educational Service for the purpose.



2. The following Notification will be published in the *Tamil Nadu Government Gazette*:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Legal Educational Service (Section 33 of volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall be deemed to have come into force on the 1<sup>st</sup> January 2006.

AMENDMENT.

In the said Special Rules, for the expression "Lecturers(Senior Scale)" and "Lecturers(Selection Grade)" wherever they occur, the expression "Assistant Professors" and "Associate Professors" shall, respectively, be substituted.
