### ORDER:

In the Government Order fifth read above, among other things, orders were issued implementing the revised University Grants Commission scales of pay to the teachers/librarians working in the Government Colleges and Universities with notional effect from 01.01.2006. In the above Government order, it has also been ordered that there shall be only three designations in respect of teachers in Universities and Colleges, namely, Assistant Professors, Associate Professors and Professors. In the Government order ninth read above, the above orders there extended to the posts in Government Law Colleges also. Accordingly, the Government have decided to amend the adhoc rules for the post of Lecturer(Senior Scale)(Pre-Law) issued in the Government order first read above, for the purpose.

2. The following Notification will be published in the *Tamil Nadu Government Gazette*:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Education Department Notification No.S.R.O.B - 498/85, dated the 19<sup>th</sup> November 1985, at pages 612-613 of Part III - Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11<sup>th</sup> December 1985, as subsequently amended.

2. The amendment hereby made shall be deemed to have come into force on the 1<sup>st</sup> January 2006.

AMENDMENT.

In the said Rules, in rule 1, for the expression "Lecturer(Senior Scale)(Pre-Law)", the expression "Assistant Professor (Pre-Law)" shall be substituted.
