## ORDER:

In the Chief Justices' Conference held on 22.04.2016 and 23.04.2016, it was resolved to strengthen and support the existing Law Schools to enhance the quality of Legal Education. A Monitoring Committee comprising of Hon'ble Judges, High Court of Madras was constituted for this purpose and the said committee had a meeting with the Director of Legal Studies on 28.06.2016 on the above subject.

- 2. In the letters second cited, the Director of Legal Studies, among others, has stated that during the said meeting of the Monitoring Committee, Hon'ble Judges stressed the urgent need to increase the sanctioned strength of teaching staff in the Government Law Colleges and informed to submit a proposal to the Government immediately. The Director of Legal Studies has therefore, submitted a proposal for the sanction of new teaching posts based on the Teacher Student ratio as per the rule of Bar Council of India and requested the Government to issue necessary orders by sanctioning 127 new full time teaching posts (120 Assistant Professors + 7 Assistant Professors (Pre Law)) to the Government Law Colleges.
- 3. The Government after careful consideration have decided to accept the request of Director of Legal Studies and accordingly sanction creation of 127 new full time teaching posts (120 Assistant Professors + 7 Assistant Professors (Pre Law)) to the Government Law Colleges as follows:-

4. The expenditure towards salary and other eligible allowances etc., of the incumbent of the said post in para 3 above shall be debited to the following head of account:-

"2202 - General Education - 03 University and Higher Education - 103 Government Colleges and Institutes-State's Expenditure - AE Law Colleges -01 Salaries (DPC.2202-03-103-AE-0101)"

- 5. The expenditure shall constitute an item of "New Instrument of Service" for which approval of the Legislature, will be obtained in due course. Pending approval of the Legislature, the expenditure will initially be met by drawal of an advance from the Contingency Fund. The Finance (BG-I) Department will issue necessary orders separately. The Director of Legal Studies is requested to apply for Contingency Fund Advance in the prescribed format, for the required amount to Finance (BG-I) Department along with a copy of this order. The Director of Legal Studies, Chennai is also requested to send necessary draft Explanatory Notes to Finance (Home-II/BG-I) Department at the appropriate time without fail.
- 6. This order issues with the concurrence of Finance Department <u>vide</u> its U.O. No.23986/DS(KP)/Home-II/2017, 28994/CMPC/2017, dated 31.05.2017 and with Additional Sanction Ledger No.564 (Five Hundred and Sixty Four).
