ORDER:

In the Government Order first read above, orders have been issued for sanction of Rs.1,14,95,000/- (Rupees One Crore Fourteen Lakh and Ninety Five Thousand only) towards construction of additional buildings for women's hostel of the Government Law College, Madurai and a sum of Rs.56,63,000/- (Rupees Fifty Six Lakh and Sixty Three Thousand only) has been released as Phase-I under Part-II Schemes for the year 2013-2014.

- 2. In the letter second read above, the Director of Legal Studies has submitted a proposal to the Government for releasing the balance sum of Rs.58,32,000/- (Rupees Fifty Eight Lakh and Thirty Two Thousand only) for the construction of additional buildings for women's hostel of the Government Law College, Madurai as Phase-II in the financial year 2014-2015.
- 3. The Government, after careful consideration, hereby accords sanction for the release of Rs.58,32,000/- (Rupees Fifty Eight Lakh and Thirty Two Thousand only) as Phase-II out of Rs.1,14,95,000/- sanctioned in the G.O.,1st read above for the construction of additional buildings for women's hostel of the Government Law College, Madurai.

4. The Expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4202 – Capital Outlay on Education, Sports, Art and culture. 01. General Education – 203. University and Higher Education – Schemes in the Twelfth Five Year Plan-II- State Plan – JA. Buildings –16. Major works (DPC 4202 – 01-203 JA 1605)."

- 5. Necessary funds will be provided in Final Modified appropriation 2014-2015. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the supplementary Estimate 2014-15. Pending provision of such funds in Final Modified Appropriation 2014-2015, the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai is authorized to incur the expenditure sanctioned in para 3 above. He is requested to include the above expenditure while sending proposals for Final Modified appropriation 2014-2015 and draft explanatory notes for supplementary Estimate 2014-15 to Government in Finance (Home-II) Department at the appropriate time, without fail.
- 6. This order issues with the concurrence of Finance Dept <u>Vide</u> its U.O.No.72955/Home-II/2014, dated 27.01.2015 and with Additional Sanction Ledger No.2294 (Two thousand two hundred and ninety four).
