#### ORDER:

In the G.O. first read above, a sum of Rs.32,50,000/- (Rupees Thirty two lakks and fifty thousand only) has been sanctioned to the Tamil Nadu Agricultural University towards the land cost for 25.00 acres of land situated in Survey Nos. 497/1, 497/2, 498/1, 498/2 and 499 at Navalur Kuttapattu Village, Srirangam taluk, Tiruchirappalli district. The Director of Legal Studies has been authorized to draw and disburse the said amount to the Tamil Nadu Agricultural University.

2. In the letter second read above, the Director of Legal Studies among others has stated that, the Head of Account "4202-01-203-JA-6404", under which the amount sanctioned in the said G.O., shall be debited is not related to the Directorate of Legal Studies. He has therefore requested the Government to issue necessary orders by giving the relevant Head of account so as to debit the sanctioned amount from the relevant Head of Account.

3. The Government, after careful consideration, have decided to issue the following amendment to G.O. (Ms.) No. 49, Law (LS) Department, dated 11.02.2015 and order accordingly:-

### AMENDMENT.

In the said G.O., for paragraphs 7-9, the following paragraphs shall be substituted, namely:-

"7. The expenditure sanctioned in para 6 above shall be debited to the following new Head of account opened under Demand No.33, HOD:02:-

"4202 – Capital outlay on Education, Sports, Art and Culture – 01 – General Education – 203 University and Higher Education – JH – Tamil Nadu National Law School, Tiruchirappalli – 64. Lands (DPC 4202-01-203-JH-6400)."

- 8. The Director of Legal Studies is the estimating, reconciling and controlling authority of the above new Head of Account.
- 9. The Pay and Accounts Officers/Treasury Officers are requested to open the above new Head of Account in their books.
- 10. Necessary funds will be provided in RE/FMA 2015-2016. Pending provision of such funds in RE/FMA 2015-2016, the Director of Legal Studies is authorized to incur the expenditure. This should be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates 2015-2016. The Director of Legal Studies, Chennai is directed to include this expenditure while sending budget proposal for RE/FMA/Supplementary Estimates 2015-2016 to Government in Finance Department at the appropriate time without fail.
- 11. This order is issued with the concurrence of Finance Department <u>vide</u> its U.O.No.38549/Home-II/2015, dated 01.09.2015 and with Additional Sanction Ledger No.896 (Eight Hundred and Ninety Six).".
