ORDER:

In the G.O. first read above, among other things, the Special Rules for the Tamil Nadu Legal Educational Service have been issued and the same was published in the Tamil Nadu Government Gazette vide the Notification second read above. The Government have decided to amend the said Notification suitably.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Education Department Notification No.SRO A-560/78, published at pp.679-682 of Part-III-Section 1(b) of the Tamil Nadu Government Gazette, dated 8<sup>th</sup> November, 1978.

2. The amendment hereby made shall be deemed to have come into force on the 8<sup>th</sup> November, 1978.

AMENDMENT.

In the said Notification, for the preamble, the following preamble shall be substituted, namely:-

“ In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and of all other powers hereunto enabling, and in supersession of the Special Rules for the Tamil Nadu Educational Service in section 8 of Volume-II of the Tamil Nadu Services Manual 1969 so far as they relate to the posts of Director of Legal Studies, Professors and Junior Professors, the Governor of Tamil Nadu hereby makes the following Special Rules for the Tamil Nadu Legal Educational Service which will be included as section 33 under Part III-A of Volume-II of the Tamil Nadu Services Manual, 1969.”.


