

### **ABSTRACT**

Tamil Nadu National Law School – Land – Tiruchirappalli district, Srirangam taluk, Navalur Kuttapattu Village – 25 acres of land in Survey Nos. 497/1, 497/2, 498/1, 498/2 and 499 – Transferred for the establishment of Tamil Nadu National Law School – Land cost – Rs.32,50,000/- Sanctioned – Orders – Issued.

#### ORDER:

In the G.O. first read above, the Government granted permission to the District Collector, Tiruchirappalli to enter upon the 25 acres of land owned by the Tamil Nadu Agricultural University in Survey Nos. 497/1, 497/2, 498/1, 498/2 and 499 at Navalur Kuttapattu Village, Srirangam taluk, Tiruchirappalli district for the purpose of establishing the Tamil Nadu National Law School.

2. In the G.O. second read above, a sum of Rs.75,00,00,000/- (Rupees Seventy five Crore only) has been sanctioned for the construction of Tamil Nadu National Law School, Trichy.

3.In the letter fourth read above the Dean, Anbil Dharmalingam Agricultural College and Research Institute, Tiruchirappalli has informed that based on the orders issued in the G.O. first read above, 25.00 acres of land belonging to Tamil Nadu Agricultural University was handed over to the Principal, Government Law college, Tiruchirappalli on 24.04.2012 and he has

stated that as indicated in the order, cost of land, trees and structures are to be paid to the Tamil Nadu Agricultural University. He has also stated that, the cost of the above land was fixed at Rs.1,30,000/- per acre by the District Revenue Officer, Tiruchirappalli in his Proceedings third read above and accordingly the cost of land for 25.00 acres works out to be Rs.32,50,000/- (Rupees Thirty two lakh and fifty thousand only). Therefore he has requested the Special Officer of the Tamil Nadu National Law School, Tiruchirappalli to pay the cost of land. The Special Officer of the Tamil Nadu National Law School, has forwarded the said request to the Government.

4.In the letter fifth read above, the Additional Chief Secretary and the Commissioner of Land Administration has stated that Patta lands of the Tamil Nadu Agricultural University are involved in the proposal and that being patta lands involved, the provision of Revenue Standing Order 23(A), on free of cost cannot be involved.

5.In the Proceedings third read above, the District Revenue Officer, Trichy has fixed the value of the land as Rs.1,30,000/- (Rupees One Lakh and thirty thousand only) per acre. Accordingly the cost of 25.00 acres of land works out to be Rs.32,50,000/- (Rupees Thirty two lakh and fifty thousand only).

- 6.The Government after careful consideration, have decided to accept the request of the Dean, Anbil Dharmalingam, Agricultural College & Research Institute, Tiruchirappalli to pay the cost of 25.00 acres of land which originally belonged to Tamil Nadu Agricultural University and subsequently handed over to the Principal, Government Law College, Tiruchirappalli for the purpose of establishing the Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam Taluk, Tiruchirappalli District. Accordingly, sanction is hereby accorded for a sum of Rs.32,50,000/- (Rupees Thirty two lakh and fifty thousand only) to the Tamil Nadu Agricultural University towards the land cost for 25.00 acres of land situated in Survey Nos. 497/1, 497/2, 498/1, 498/2 and 499 at Navalur Kuttapattu Village, Srirangam Taluk, Tiruchirappalli district.
- 7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:-

"4202 Capital Outlay on Education – 01 – General Education – 203 – University and Higher Education – JA. Buildings – 64.Lands. (DPC 4202 – 01-203 – JA – 6404)."

8. The expenditure sanctioned in para 6 above shall constitute an item of "New Instrument of Service" for which approval of the Legislature, will be obtained in due course. Pending approval of the Legislature, the expenditure will initially be met by drawal of an advance from the Contingency Fund. The Finance (BG-I) Department will issue necessary orders separately. The Director of Legal Studies is authorized to draw and disburse the said amount to the Tamil Nadu Agricultural University. He is also requested to apply for Contingency Fund Advance in the prescribed format, for the required amount to Finance (BG-I) Department along with a copy of this order. The

Director of Legal Studies, Chennai is also requested to send necessary draft Explanatory Notes to Finance (Home-II/BG-I) Department at the appropriate time without fail.

9. This order issues with the concurrence of Finance Department vide its U.O.No.3573/Home-II/2015, dated 06.02.2015 and with Additional Sanction Ledger No.2427 (Two thousand four hundred and twenty seven).
