## ORDER:

In the G.O. first read above, administrative sanction was accorded for Rs.75 crore for the construction of the Tamil Nadu National Law School, Tiruchirappalli. In the G.O. second read above, revised administrative sanction was accorded for a sum of Rs.79,21,50,587/- to the said construction work.

- 2. In the letter third read above, the Engineer in Chief (Buildings) and Chief Engineer (Buildings), Public Works Department has submitted the rough Cost Estimate for according administrative sanction of the Government for Rs.23.35 crore for further construction work of the Tamil Nadu National Law School in phase-II.
- 3. The Government after careful consideration, have decided that the entire estimate need not be sanctioned in one shot and have drawn up a priority list in consultation with the Vice-Chancellor of the Tamil Nadu National Law School and hereby accord sanction for a sum of Rs.7,16,62,000/- (Rupees Seven Crore Sixteen Lakh and Sixty Two Thousand only) for the works listed at priority I and II as detailed below:-

Along with lump sum provisions, total cost of priority II is sanctioned as Rs.1,60,26,000/- (Rupees One Crore Sixty Lakh and Twenty Six Thousand only).

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4202 Captial Outlay on Education, Sports, Art and culture - 01. General Education - 203. University and Higher Education - Schemes in the Twelth Five Year Plan.-II- State Plan - JA. Buildings - 16. Major works (DPC 4202 - 01-203 JA 1605)."

- 5. The expenditure sanctioned in para 3 above shall constitute an item of "New Service" and the approval of Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Engineer-in-Chief (Buildings) and Chief Engineer(Buildings), Chennai Region, Public Works Department, Chennai is directed to calculate the actual amount required for the period up to next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance(B.G.I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Engineer-in-Chief(Buildings) Department. The and Chief Finance(B.G.I) Engineer (Buildings), Chennai Region, Public Works Department, Chennai shall also send necessary explanatory notes to the Government in Finance(BG.I/Home-II) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2015-2016, at the appropriate time without fail.
- 6. This order issues with the concurrence of Finance Department <u>Vide</u> its U.O. No.9020/DS/KP/Home-II/2016, dated 10.02.2016 and with ASL No.2298 (Two Thousand Two Hundred and Ninety Eight).
