ORDER:

The Ministry of Urban Development had launched the "Swachh Bharath Mission" (SBM) on 02.10.2014 for a period of five years. The Mission Objectives are (i) Elimination of open defecation, (ii) Eradication of manual scavenging, (iii) Modern and scientific Municipal Solid Waste Management, (iv) To effect behavioral change regarding healthy sanitation practices, (v) Generate awareness about sanitation and its linkage with public health, (vi) Capacity augmentation for Urban Local Bodies, and (vii) To create an enabling environment for Private sector participation in Capex (Capital Expenditure) and Opex (Operation and Maintenance expenditure).

- **2.** All Statutory towns will be covered under the Mission. As per the guidelines 'Statutory towns' (defined by Census 2011) are urban areas defined by administrative units that have been defined by 'statute' as urban, such as municipal corporations, municipalities, cantonment boards, notified town area committees, town panchayats, or nagar palikas.
- **3.** Government of India has proposed that the state wise allocations under the mission would be based on total urban population (50% weightage) and total number of statutory towns (50% weightage). Subsequently, the allocation would be based on actual requirements and utilizations. The following are the Tentative Targets and Financial Incentives proposed by Government of India under the components of the mission:

4. The **components** of the Swacch Bharat Mission in brief are

- (i) **Household toilets -** component rests on the aims to ensure that 'no households engage in the practice of open defecation; no new insanitary toilets are constructed during the mission period and pit latrines are converted to sanitary latrines'.
- (ii) Community toilets Community toilet blocks will consist of a given number of toilet seats, as per requirements. Pour flush, with facilities like washing, bathing etc, and separate toilets and bathing facilities for men, women and facilities for the disabled. All community toilets constructed under Swacch Bharat Mission must have a minimum 5 year maintenance contract.
- (iii) Public Toilets Construction of sufficient number of public toilets in each city, with coverage of all prominent places within the city attracting floating population. Adequate provision for men, women and facilities for the disabled, wherever necessary are to be ensured. There will be no Central Government incentive support under this component. Urban Local Bodies are encouraged to identify land for public toilets, and leverage this land and advertisements to encourage the private sector to construct and manage public toilets through a Public Private Partnership agreement. All Public Toilets constructed under Swachh Bharat Mission must have a minimum 5 year maintenance contract. The Urban Local Bodies can utilize the proceeds of the advertisements and user fee to meet the maintenance expenditure.
- **(iv) Solid Waste Management** Urban Local Bodies have to prepare Detailed Project Reports (DPRs) with reference to the Manual on Municipal Solid Waste Management, 2000 published by the Ministry of Urban Development. The State High Powered Committee will approve the Detailed Project Reports, financial model and implementation will be as per directions of the State High Powered Committee.
- **(v) IEC and Public Awareness -** A key strategy under Swahh Bharat Mission is behavior change communication to ensure that sanitation as an issue is mainstreamed with the general public at large and should cover issues of open defecation, prevention of manual scavenging, hygiene practices, proper use and maintenance of toilet facilities (household, community or otherwise), etc., and its related health and environmental consequences. A total of **15%** of the total central allocation will be earmarked for this component. Of this, **12%** will be earmarked for States to undertake massive public awareness campaigns on sanitation and establishing its link to public health, hygiene and the environment.

States shall prepare an annual action plan for Public Awareness and IEC and State High Powered Committee shall approve it.

- (vi) Capacity Building and Administrative and Office Expenses (A&OE) 3% of the total Central Government allocation under the mission will be earmarked for capacity building, administrative and office expenses of States and ULBs. States shall propose extensive capacity building activities to be implemented in a mission-mode manner in their comprehensive annual action plans approved by the State High Powered Committee. 50% of the funds must go towards Urban Local Body level activities.
- **5.** The details of the activities proposed by the State under the various components of the Mission, viz., the funding pattern, unit cost, number of units proposed, the proposed number of beneficiaries etc., are annexed to this order.
- **6.** Guidelines of the Swachh Bharat Mission envisages at the **National Level**, a National Advisory and Review Committee headed by the Secretary, Ministry of Urban Development, and a Swachh Bharat Mission National Mission Directorate headed by a National Mission Director.
- **7.** At the **State level**, a High Powered Committee has to be constituted. The Director of Municipal Administration has proposed that the Project Sanctioning Committee for approving projects under Solid Waste Management Fund constituted vide Government Order first read above, with the inclusion of a representative of the Ministry of Urban Development, Government of India, may be mandated to serve as the State High Powered Committee under the Swacch Bharat Mission.
- **8.** The functions of the Committee includes (i) preparation, approval and online publishing of the State Sanitation Strategy and City Sanitation Plan for all cities covered under Swachh Bharat Mission (ii) sanction of projects relating to Solid Waste Management recommended by the Urban Local Bodies (iii) review and monitoring during execution of projects (iv) recommend proposals for release of installments of funds for projects under the mission (v) review the progress of Capacity Building, IEC and Public Awareness activities under the mission and approve their annual action plan.
- **9.** The guidelines also speak of constitution of a **Mission Directorate** at the State level. As per the guidelines, the State Mission Directorate will create/ notify a uniform structure across the State for the planning, designing, appraisal, sanction and implementation of sanctioned projects under the mission at the Urban Local Body level, taking into account, the advisories issued by the National Mission Directorate from time to time. Accordingly, the Director of Municipal Administration has proposed to constitute the State Mission Directorate with the following composition, to be located within the Directorate of Municipal Administration:-

- **10.** The Director of Municipal Administration has proposed that after the formation of the State Mission Directorate and on the receipt of framework for the support structure to the State Mission Directorate from the National Mission Directorate, the Project Management Unit on an out-sourced basis may be formed and necessary proposal will be sent to the Government in this regard.
- **11.** As per the guidelines issued by the Ministry of Urban Development, Government of India, the District Level Review and Monitoring Committee with the following composition may be constituted, to monitor the progress of the implementation of the Swachh Bharat Mission, by the respective District Collector in consultation with the State Mission Director, Swachh Bharat Mission.

The Government after careful examination of the proposal of the Director of Municipal Administration has decided to accept same and accord administrative sanction for the implementation of the Swachh Bharat Mission in the State, with funding pattern under various components of the Mission as detailed at Annexure to this Order.

13. The Government also constitute the **State Mission Directorate**, with the composition, as detailed below:

- **14.** Further, the Government has decided to authorize the Project Sanctioning Committee for approving projects under Special Solid Waste Management Fund, constituted vide Government Order first read above, to function as High Powered Committee with the inclusion of the representative from the Ministry of Urban Development, Government of India.
- **15.** The Government also directs the respective District Collectors to constitute the District Level Review and Monitoring Committee as below, in consultation with the State Mission Director, Swachh Bharat Mission:
