ORDER:

In the Government Order first and second read above orders were issued for constitution of a Joint Committee at District Level with the composition of 29 officials for supervising the sanitation and basic amenities and infrastructure facilities monitoring and supervising the works relating to Mahamaham Festival, 2004.

2. In the letter third read above, the Commissioner of Municipal Administration has stated that during the Mahamaham festival, people will throng to the Temple Town and Kumbakonam from across the Country and the Town will witness huge rush of Pilgrims. So, it is essential to provide required amenities to the pilgrims. The Municipal Commissioner, Kumbakonam has stated that during the previous Mahamaham Festival 2014, the Government issued orders for constitution of a Joint Committee at District Level with the composition of 27 officials for supervising the arrangements for sanitation and basic amenities and monitoring the proposed expenditure. The Municipal Commissioner, Kumbakonam has now requested to constitute the Joint Committee at District Level for the proposed Mahamaham, 2016 festival. The District Collector, Thanjavur has also requested the order for forming the above Committee. The Commissioner of Municipal Administration has requested the Government to constitute a District Level Co-ordination Committee with the composition of 32 officials.

3. After careful examination, the Government have decided to constitute the District Level Co-ordination Committee at District Level with the following 26 members for supervising and monitoring the works relating to the ensuing Mahamaham Festival, 2016 at Kumbakonam Town:-
