### **ORDER:**

During the Budget Speech for the year 2014-15, the Hon'ble Minister for Finance has made the following announcement:-

**"To improve the infrastructure in Town Panchayats, 425.92 Km of road works, 75 Storm water drains and 42 bridges have been taken up at an estimated cost of Rs.140 Crore under the NABARD scheme for the year 2013-2014. During 2014-2015, 273 road works to a length of 388 Km, 105 Storm Water drain works to a length of 124.96Km and 29 bridges will be taken up at an estimated cost of Rs.150 Crore under NABARD-RIDF scheme"**

2. Accordingly, the Director of Town Panchayats in the letter first read above has sent proposal for Improvement of roads, construction of bridges and Storm water drains and requested the Government to consider and recommend the proposal for approval of 407 works at an estimated cost of Rs.150.00 Crore to NABARD for necessary approval and allotment of funds under NABARD RIDF-XX for the year 2014-15. The Sector wise details are as follows:-

In the letter third read above the Government in Finance (Res-II) Department has stated that the Deputy General Manager, NABARD, Chennai has informed that the Project Sanctioning Committee (PSC) in its 144<sup>th</sup> meeting has sanctioned RIDF loan of a sum of Rs.92.06 Crore to Government of Tamil Nadu for the year 2014-2015 under NABARD RIDF-XX with the following funding pattern:-

The Government have decided to accord Administrative Sanction for the Improvements to 12 rural roads in 8 Town Panchayats and 1 bridge in one Town Panchayat in Tiruchirappalli and Pudukottai Districts at an estimated cost of Rs.5.50 Crore (Rupees Five Crore and Fifty Lakhs Only) as Annexed (I and II) to this order under NABARD assisted RIDF -XX scheme for the year 2014-2015 and order accordingly.
