ORDER:

The scope of the revolving fund created under the Union Government sponsored erstwhile "Mega City Program" named as "Metropolitan Infrastructure Development Fund (MIDF)" has been recently expanded, enabling it to provide finance to all the Urban Local Bodies in the State to meet their infrastructure requirements in the form of soft loans. The Fund has been renamed as "State Urban Infrastructure Development Fund (SUIDF)" and the State Level Sanctioning Committee under the renamed Fund has also been restructured. Administrative Sanction in this regard has been issued vide the Government Order second read above.

2. The Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development

Corporation Limited in his proposal fourth read above has stated that, the State Level Sanctioning Committee under State Urban Infrastructure Development Fund at its first meeting held on 20.07.2022, among others, has considered the proposal of the Director of Municipal Administration for providing a loan of Rs.342.85 crore to the project of "Conversion of existing street lights into LED lights in 8 City Municipal Corporations and 76 Municipalities and a loan of Rs.8.00 crore for providing new LED lights in 11 Municipalities".

3. The Director of Municipal Administration has proposed that, totally 3,00,796 Numbers of conventional street lights will be converted into LED lights at a project cost of Rs.342.85 crore. Power consumption will be reduced up to 40% and it is estimated that, there will be a savings of about Rs.65.00 crore per year for the ULBs due to the conversion of 3,00,796 street lights into energy efficient LED lights and installation of 5,106 Numbers of new LED lights at a cost of Rs.8.00 crore in 11 Municipalities in the added area / left out areas. Energy efficiency, brightness levels, safety for traffic, low maintenance costs and environmental safety are the benefits of the projects.

4. Considering the financial status of Corporations and Municipalities and to repay the loan through State Finance Commission grants, the Director of Municipal Administration requested approval of the State Level Sanctioning Committee for providing loan to the above project at an interest rate of 5% with repayment period of 10 years.

5. The Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has appraised the above projects and after detailed deliberations, the State Level Sanctioning Committee under State Urban Infrastructure Development Fund has approved for providing loan to the project of "Conversion of existing street lights into energy efficient LED lights in 8 City Municipal Corporations and 76 Municipalities (3,00,796 Numbers)" (Details are given in Annexure-I) and also for providing a loan of Rs.8.00 crore for providing new LED lights in 11 Municipalities (5,106 Numbers) (Details are given in Annexure-II) under State Urban Infrastructure Development Fund, at an interest rate of 5% per annum with repayment period of 6 years, subject to the following conditions:

- i. The respective Urban Local Body to obtain council resolution for availing loan from Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, for conversion of street light into LED lights and submit the same to Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.
- ii. The Director of Municipal Administration has already appointed a Third party monitoring agency to check the quality of lights and review the savings. The services of third party monitoring agency can be extended to Town Panchayats also.
- iii. The Third party monitoring agency has to submit the details of energy savings on installation of LED street lights in respective Urban Local Body to Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, on monthly basis.

- iv. The contract should have inbuilt provisions for replacement of the lights, providing new lights and to carry out the operation and maintenance of Street lights for 10 year period.
- v. The repayment of loan amount is to be met out from energy savings of street lights as a priority. The Urban Local Bodies have to open a separate ESCROW account to manage the savings and repayment of loan to Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.
- vi. In respect of Urban Local Bodies which are not having adequate savings for replacement of street lights with LED lights, the Director of Municipal Administration should ensure that the balance loan amount is adjusted with State Finance Commission grants.

6. Accordingly, the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to issue necessary orders for conversion of existing street lights with energy efficient LED lights in various Urban Local Bodies under State Urban Infrastructure Development Fund.

7. The Government after careful examination of the proposal of the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, seeking orders for implementation of the project under State Urban Infrastructure Development Fund, as below, subject to the conditions specified in the appraisal reports of respective projects and as approved by the State Level Sanctioning Committee during its first meeting held on 20.07.2022, have decided to accept the same and order accordingly:-

- (i) to provide a loan for an amount of Rs. 342.85 crore (Rupees three hundred and Fourty two crore eighty five lakh only) from State Urban Infrastructure Development Fund to the project "Conversion of existing street lights into energy efficient LED lights in 8 City Municipal Corporations and 76 Municipalities (3,00,796 Numbers)" (Details are given in Annexure-I) at an interest rate of 5% per annum, with repayment period of 6 years, subject to the conditions specified in paragraph 5 above.
- (ii) to provide a loan for an amount of Rs.8.00 crore (Rupees Eight crore only) from State Urban Infrastructure Development Fund for providing new energy efficient LED lights in 11 Municipalities (5,106 Numbers) (Details are given in Annexure-II) at an interest rate of 5% per annum, with repayment period of 6 years, subject to the conditions specified in paragraph 5 above.

8. The Government also direct that, the recommendations of the Committee on Rate finalisation for procurement of LED lamps, fittings and energy saving equipments for Corporations, Municipalities and Town Panchayats, headed by the Deputy Secretary to Government, Finance Department, made in the minutes of its meeting held on 25.04.2022 shall be strictly adhered to, in respect of the above energy efficient LED lights projects.

9. This order issues with the concurrence of the Finance Department vide its U.O.No.21/DS/(LBT)/Fin(MAWS)/2022, Dated 13.10.2022.
