## ORDER:-

With the aim of involving every citizen in the journey towards garbage free cities, a special campaign (i.e) the 'People's Movement for Clean Cities' is being implemented in the State and guidelines for the implementation of the above Campaign and Cleanliness Pledge have been issued vide Government order first read above.

- **2.** In the letter second read above, the Director of Municipal Administration has suggested certain amendments to the above order and has requested for necessary orders of the Government.
- **3.** The Government after careful examination of proposal of the Director of Municipal Administration has decided to accept the same and accordingly issue the following amendment:-

## **Amendment**

In the Government order  $1^{st}$  read above, for the existing paragraph 4, the following paragraph shall be substituted namely.,

- "4. The Director of Municipal Administration has further stated that, the following thematic activities have been planned as given below to inculcate proper sanitation on regular basis i.e. every 2<sup>nd</sup> and 4<sup>th</sup> Saturdays of the month and on continual basis:-
  - (a) Mass cleaning of public areas.
  - **(b)** Sensitizing about source segregation.
  - (c) Cleaning of water bodies / storm water drains and mass tree planting

- (d) Removal of unauthorized hoardings / boards
- (e) Felicitate the Champion Workers and Volunteers
- (f) Removal of unauthorizedly dumped Construction and Demolition Waste and complete removal of Wall Posters.
- **4.** The Government has also decided that, Awareness campaign on solid waste management and cleanliness be conducted in Schools and Colleges on third Wednesday of every month.
- **5.** The Heads of Department are requested to pursue necessary action in this regard.
