ORDER:

The Ministry of Housing and Urban Affairs, Government of India has launched its flagship programme, namely, "Atal Mission for Rejuvenation and Urban Transformation 2.0" (AMRUT 2.0) on 01.10.2021. The key components of the Atal Mission for Rejuvenation and Urban Transformation 2.0 are (a) Universal coverage of water supply; (b) Sewerage, Septage management and recycle / reuse of treated used water; (c) Rejuvenation of water bodies (including urban wet lands) and creation of green spaces.

2. Administrative Sanction for implementation of Atal Mission for Rejuvenation and Urban Transformation 2.0. has been accorded and the State High Powered Steering Committee (SHPSC) headed by the chairmanship of the Chief Secretary to Government has been constituted for the approval of the Projects under the Mission, vide the G.O first read above.

3. In the letter third read above, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that, the State High Powered Steering Committee (SHPS) of Atal Mission for Rejuvenation and Urban Transformation 2.0 during its 4th meeting held on 14.09.2022 vide the minutes 2nd read above, among others, has approved the following projects:

i) Under Ground Sewerage Scheme (UGSS) projects

The State High Powered Steering Committee has approved 7 UGSS projects of Chennai Metropolitan Water Supply and Sewerage Board at a total appraised project cost of Rs. 1,463.14 crore under Atal Mission for Rejuvenation and Urban Transformation 2.0 Tranche-II FY 2022-23 as given in the Table below:

ii) Reimbursement of Rs.1.75 crore to Chennai Metropolitan Water Supply and Sewerage Board towards 'Maintenance of Rain Water Harvesting structures and Mass campaign to create awareness for the year 2022-2023'

The Chennai Metropolitan Water Supply and Sewerage Board has proposed to launch a nearly one month long campaign to create awareness about rainwater harvesting; assessing the status of rainwater harvesting structures in the city; water quality monitoring; etc., by utilizing the services of Women Self Help Group Members. The State High Powered Steering Committee in its 4th meeting has also approved to reimburse Rs.1.75 crore to Chennai Metropolitan Water Supply and Sewerage Board towards 'Maintenance of Rain Water Harvesting structures and Mass campaign to create awareness for the year 2022-23', under Administrative & Other Expenses (A&OE) Fund of Atal Mission for Rejuvenation and Urban Transformation 2.0.

4. Accordingly, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to issue necessary Administrative orders for the above projects.

5. The Government after careful examination of the proposal of the Mission Director, Atal Mission for Rejuvenation and Urban Transformation Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, have decided to accept the same and accordingly issue administrative orders for implementation of 7 UGSS projects of Chennai Metropolitan Water Supply and Sewerage Board at a total approved project cost of Rs.1,463.14 crore (Rupees one thousand four hundred sixty three crore and fourteen lakh only) under AMRUT 2.0 Tranche-II FY 2022-23 and for reimbursement of Rs.1.75 crore (Rupees one crore and seventy five lakh only) to Chennai Metropolitan Water Supply and Sewerage Board towards 'Maintenance of Rain Water Harvesting structures and Mass campaign to create awareness for the year 2022-23', under Administrative and Other Expenses (A&OE) Fund of Atal Mission for Rejuvenation and Urban Transformation 2.0. as approved by State High Powered Steering Committee during its 4th meeting held on 14.09.2022, detailed at para 3 above.
