### **ORDER:**

The Swachh Bharat Mission - Urban 2.0 has been launched by the Ministry of Housing & Urban Affairs, Government of India on 01.10.2021 for a period of 5 years (2021-2026), with a vision of achieving "Garbage Free" status for all cities.

2. In the Government Order first read above, administrative sanction has been accorded for the implementation of the Union sponsored Swachh Bharat Mission 2.0 in the State and the Director of Municipal Administration has been designated as the State Mission Director and the Directorate of Municipal Administration has been designated as the State Mission Directorate.

3. In the Government Order fourth read above, Government has released Rs.7.00 crore being the Central share of Swachh Bharat Mission for IEC activities under Swachh Bharat Mission (U) 2.0, for 2021-22.

4. In the letter sixth read above, the Mission Director (SBM)/ Director of Municipal Administration has stated that in the letters third and fifth read above, a sum of Rs. 4,90,20,000/- (Rupees four crore ninety lakh and twenty thousand only) has been released by Government of India as (against the sanctioned amount of Rs.15,61,20,000/-) Central Share of Swachh Bharat Mission for the implementation of IEC activities under Swachh Bharat Mission (U) 2.0 during 2021-2022.

5. The Director of Municipal Administration has also stated that the details of the amount received are as below:

The Director of Municipal Administration has therefore requested the Government to issue necessary order for release of a sum of Rs.4,90,20,000/- (Rupees Four Crore ninety lakh and twenty thousand only) to the Directorate of Municipal Administration being the Central share of IEC component under Swachh Bharat Mission in Urban Local Bodies of Tamil Nadu.

7. The Government after careful examination of the proposal of the Director of Municipal Administration has decided to accept the same and accord sanction and release of a sum of Rs. 4,90,20,000/- (Rupees four crore ninety lakh and twenty thousand only) to Director of Municipal Administration as Central share of Swachh Bharat Mission 2.0 for implementation of IEC activities under Swachh Bharat Mission (U) 2.0 during 2021-2022.

8. The amount sanctioned in para 7 above shall be debited to the following heads of accounts:
