ORDER:

In the Government Order third read above, administrative sanction for taking up National Urban Livelihoods Mission in the State has been accorded. The Annual Action Plan under National Urban Livelihoods Mission for the year 2014-15 with a total outlay of Rs.14307.27 lakhs has also been approved vide the said Government Order. The central assistance for the Mission for the year 2014-15 is Rs.10730.45 lakhs and the matching State share is Rs.3576.82 lakhs.

2. The Government of India has sanctioned and released Grants-in-aid under the National Urban Livelihoods Mission for the year 2014-15 to the State as detailed below:-
