ORDER:

In the Government Order read above, it has been ordered that in respect of two cases where the adhoc pensioners had not put in minimum 10 years qualifying service are not eligible for regular pension and where the amount of adhoc pension paid could not be recovered, the same may be waived as per G.O.Ms.No.512, Municipal Administration and Water Supply Department, dated 23.4.1986.

2. The Examiner of Local Fund Accounts has raised a doubt that whether the living adhoc pensioners who had not put in minimum 10 years of qualifying service are eligible for regular pension. Proposals are being received in the Office of the Examiner of Local Fund Accounts from several living adhoc pensioners for regularisation of pension and it is found that they are not eligible for regular pension as the qualifying service falls below the minimum 10 years prescribed under the rules for eligibility of the pension. The adhoc pension was sanctioned to all retired Municipal employees who retired prior to 14.1.70 irrespective of the duration of service and no qualifying service was stipulated vide G.O.Ms.No.1770, Rural Development and Local Administration Department dated 24.8.1972. He has therefore suggested that the monthly adhoc pension may be continued to be paid till death from the respective municipal funds and that after death, family pension may be paid to eligible legal heirs in terms of Family Pension Rules, 1964 and orders issued in G.O.Ms.No.748, Finance (Pay Cell) Department dated 26.5.1979 from the Municipal Employees Pension Fund maintained by the Examiner of Local Fund Accounts, after collecting pension contribution for the service rendered as ordered in G.O.Ms.No.512 Municipal Administration and Water Supply Department dated 23.4.1986.

3. The Government have examined the proposal and direct that the monthly adhoc pension may be continued to be paid till death from the respective Municipal funds. After death, family pension may be paid to eligible legal heirs in terms of Family Pension Rules, 1964 and orders issued in G.O.Ms.No.748 Finance (Pay Cell) Department dated 26.5.1979, from the Municipal Employees Pension Fund maintained by the Examiner of Local Fund Accounts after collecting pension contribution for the service rendered as ordered in G.O.Ms.No.512 Municipal Administration and Water Supply Department dated 25.4.1986.

4. This order issues with the concurrence of Finance Department vide its U.O.No.18102/Pen/90-1 dated 21.2.1990.


