ORDER:

In the Government Order read above, the Government have accorded Administrative Sanction for construction of Bridges, Storm Water Drains and Modern Slaughter Houses at an estimated cost of Rs.37.00 Crore under the loan assistance of NABARD (RIDF XIX) for the year 2013-14 and the details of the project cost are as below:-

Further the Deputy General Manager, NABARD in his letter dated 19.08.2014 has informed that the proposal for construction of Storm Water Drain at an estimated cost of Rs.21.60 Crore is not eligible activity under RIDF and requested to consider to treat the storm water drain (75 works) projects as withdrawn.

3. In the letter second read above, the Director of Town Panchayats has sent the proposal and requested the Government to release a sum of Rs.15.40 Crore under NABARD RIDF (XIX) for the year 2013-14 for construction of Bridges and Modern Slaughter house. Further, he has also informed that the necessary action has been taken up for the execution of Bridges and Slaughter house Projects in Town Panchayats and works are under progress in various stages.

4. The Government after careful consideration, accept the proposal of the Director of Town Panchayats accord sanction and release a sum of Rs.15.40 Crore under the loan assistance of NABARD (RIDF XIX) for the year 2013-2014 for the **"Construction of Bridges and Modern Slaughter House in Town Panchayats** as detailed below:-
