### **ORDER:**

In the Government Order first read above, administrative sanction for taking up National Urban Livelihoods Mission in the State has been accorded. The funding pattern for the National Urban Livelihoods Mission is 60:40 between Government of India and Government of Tamil Nadu.

2. In the letter second read above, the Executive Director, Tamil Nadu Corporation for Development of Women Limited has stated that the Government of India have sanctioned a sum of Rs.6,00,00,000/- (Rupees six crore only) towards 3<sup>rd</sup> award in SPARK ranking (Systematic Progressive Analytical Real Time Ranking) for the year 2020-21, under General, SCSP and TSP categories of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission.

3. The Executive Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to sanction an amount of Rs.10,00,00,000/- (Rupees Ten crore only) under Deendayal Antyodaya Yojana-National Urban Livelihoods Mission towards Central and State matching share of 60% and 40% respectively as detailed below:

The Government after careful examination, accept the proposal of the Executive Director, Tamil Nadu Corporation for Development of Women Limited and sanction an amount of Rs.10,00,00,000/- (Rupees Ten crore only) i.e. Central share of Rs. 6,00,00,000/- (Rupees Six crore only) and State matching share of Rs. 4,00,00,000/- (Rupees Four crore only) towards 3<sup>rd</sup> award in SPARK ranking for the year 2020-21 under Deendayal Antyodaya Yojana - National Urban Livelihoods Mission. The proposed amount will be met from existing Budget Estimate 2022-2023 provision.
