ORDER:

In the Government Order first read above, the Government has accorded administrative sanction for implementation of World Bank assisted Tamil Nadu Sustainable Urban Development Project. The total outlay of the project is US \$ 600 million equivalent to about Rs.3831 crore, of which World Bank assistance is US \$ 400 million equivalent to about Rs.2554 crore. The project has been restructured by reallocating the funds within the components of the project during July 2020 and June 2021. The Government, vide Government Order third read above has issued orders for ratification for restructuring of Tamil Nadu Sustainable Urban Development Project made in July 2020 and June 2021 and approval for revised allocation amongst various components consequent to restructuring and exchange rate variation. The revised total outlay of the project is US \$ 609 million equivalent to about Rs.4104.86 crore, of which World Bank assistance is US \$ 400 million equivalent to about Rs.2770.39 crore. The project implementation period is from June 2015 to March 2022 and has been extended up to March 2023.

- 2. The revised allocation for grant to Project Development Grant Fund towards Technical Assistance (TA) for projects / credit enhancement /Tamil Nadu Urban Development Fund Technical Assistance (TA)/ Corporation of Chennai Technical Assistance under the Investment in Urban Services Componentis US \$ 24.00 million (Bank finance of US \$ 15.00 million plus Government of Tamil Nadu finance of Rs.110.01 crore plus Government of Tamil Nadu finance of Rs.57.47 crore).
- **3.** In the letter fourth read above, the Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has stated that a sum of Rs.113.03 crore has been committed as TA grant for various consultancy assignments. A sum of Rs.75 crore has been released by the Government and a sum of Rs.62.35 crore has already been disbursed and the balance amount available is Rs.12.65 crore only.
- 4. The Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has requested the Government to release a sum of Rs.35 crore as Technical Assistance grant under the World Bank assisted Tamil Nadu Sustainable Urban Development Project from the Budget Estimate 2022-2023 to the Project Development Grant Fund, considering the Technical Assistance grant already disbursed to consultancy assignments and requirement of funds for the ongoing consultancy assignments.
- **5.** The Government after careful examination, accept the proposal of the Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited and accord sanction for release of a sum of Rs.35,00,00,000/- (Rupees Thirty five crore only) to Project Development Grant Fund towards Technical Assistance for various ongoing consultancy assignments under Tamil Nadu Sustainable Urban Development Project.
- **6.** The amount sanctioned in para 5 above shall be debited to the following Head of account:-

"2217 Urban Development – 80 General – 800 Other Expenditure – Externally Aided Projects – PH Technical Assistance to World Bank assisted Tamil Nadu Sustainable Urban Development Project with TNUDF - 09 Grants in Aid - 03 Grants for Specific Schemes.
