ORDER:

In the Government Order first read above, the Government have accorded administrative sanction for the implementation of Asian Development Bank (ADB) assisted Tamil Nadu Urban Flagship Investment Program (TNUFIP) – Tranche-1. The total outlay of Tamil Nadu Urban Flagship Investment Program Tranche-1 is US \$ 477.50 million equivalent to about Rs.3070.33 crore, of which ADB assistance is US \$ 171 million (Loan of US \$ 169 million and Grant of US \$ 2 million) equivalent to about Rs.1099.53 crore. An amount of Rs.78.90 crore has been allocated as grant to Project Development Grant Fund for providing technical assistance for consultancy assignments (Rs.71.83 crore) and incremental administrative costs (Rs.7.07 crore). Of the above allocation of Rs.71.83 crore for consultancy assignments, a sum of Rs.75.29 crore has been committed to Construction Management and Supervision Consulting assignments and other assignments.

2. The Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has stated that, a sum of Rs.29.50 crore has been released by the Government under the Asian

Development Bank assisted Tamil Nadu Urban Flagship Investment Program (TNUFIP) – Tranche-1 as detailed below:

3. The Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has also stated that, of the amount released by Government, a sum of Rs.25.04 crore has already been disbursed and the balance amount available is Rs.4.46 crore only.

4. The Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has further stated that, the Government has provided a sum of Rs.29.00 crore as grant under Tamil Nadu Urban Flagship Investment Program-Tranche-1 in the Budget Estimate 2022-23 under the head Technical Assistance to Project Development Grant Fund for implementation of Asian Development Bank assisted Tamil Nadu Urban Flagship Investment Program.

5. The Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has requested that, considering the requirement of funds for the ongoing consultancy assignments, a sum of Rs.29,00,00,000/- (Rupees twenty nine crore only) may be released to Project Development Grant Fund under Tamil Nadu Urban Flagship Investment Program-Tranche-1 out of the Budget Estimate 2022-23. The Technical Assistance grant of Rs.29.00 crore may be released to the non-interest bearing Public Deposit Account No. 30728644639 maintained in the name of Grant Fund.

6. The Government after careful examination of the proposal of the Chairman and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited, have decided to accord sanction for release of a sum of Rs.10,00,00,000/- (Rupees ten crore only) as Technical Assistance Grant to Project Development Grant Fund under Asian Development Bank assisted Tamil Nadu Urban Flagship Investment Program-Tranche-1.

7. The amount sanctioned in para-6 above shall be debited to the following head of account:

"2217 - Urban Development - 80 - General - 800 - Other Expenditure - Externally Aided Projects - PI - Technical Assistance to Project Grant Fund (PDGF) for implementation of Asian Development Bank assisted Tamil Nadu Urban Flagship Investment Programme (TNUFIP) - 309 - Grants-in-Aid - 03 Grants for Specific Schemes."
