ORDER:-

The Swachh Bharat Mission (Urban) 2.0 has been launched by the Ministry of Housing & Urban Affairs, Government of India on 01.10.2021, for a period of 5 years (2021-2026), with a vision of achieving "Garbage Free" status for all cities.

- 2. In the Government Order first read above, administrative sanction has been accorded for the implementation of the Union sponsored Swachh Bharat Mission 2.0 in the State. The Director of Municipal Administration has been designated as the State Mission Director and the Directorate of Municipal Administration has been designated as the State Mission Directorate.
- **3.** In the letter third read above, the State Mission Director, Swachh Bharat Mission and the Director of Municipal Administration has stated that, in letter second read above, an amount of **Rs. 384,66,30,000/-** (Rupees three hundred eighty four crore sixty six lakh and thirty thousand only) has been released by Government of India as first instalment of Central Share under Swachh Bharat Mission 2.0, 2022-23, for the implementation of the components of Used Water Management, Individual

House Hold Latrine, Community Toilet, Public Toilet and Aspirational Toilets. The details of the amount received are as follows:-

The State Mission Director, Swachh Bharat Mission and the Director of Municipal Administration has therefore requested the Government to issue necessary order to release a sum of Rs.384,66,30,000/-(Rupees three hundred eighty four crore sixty six lakh thirty thousand only) for implementation of Swachh Bharat Mission (Urban) 2.0 in Urban Local Bodies of the State.

- **6.** The Government after careful examination of the proposal of the State Mission Director, Swachh Bharat Mission and the Director of Municipal Administration has decided to accept the same and accord sanction and release of a sum of **Rs. 384,66,30,000/-** (Rupees three hundred and eighty four crore sixty six lakh and thirty thousand only) as first instalment of Central Share of Swachh Bharat Mission 2.0, 2022-23 for the implementation of the components of Used Water Management, Individual House Hold Latrine, Community Toilet, Public Toilets.
- **7.** The amount sanctioned in para 6 above shall be debited to the following heads of accounts:
