#### **ORDER:**

In the Government Order first read above, administrative sanction was accorded for the improvement of 192 road works to a length of 292.659 Km in 147 Town Panchayats in 31 Districts at an estimated cost of Rs.181.30 Crore and Construction of 11 Bridge works in 7 Town Panchayats in 6 Districts at a cost of Rs.19.40 Crore at an total outlay of Rs.200.70 Crore under NABARD RIDF XXVII Scheme for the year 2021-22.

2. In the Government Order second read above, sanction was accorded to release a sum of Rs.56,81,81,000/- for improvement and Strengthening of 192 road works to a length of 292.659 KM in 147 Town Panchayats under NABARD (RIDF-XXVII) for the year 2021-22.

3. In the Government Order third read above, the Revised Administration Sanction was accorded for improvement of 192 road works to a length of 292.659 KM in 147 Town Panchayats in 31 districts at a cost of Rs.189.68 Crore and construction of 11 Bridge works in 7 Town Panchayats in 6 districts at a cost of Rs.19.40 Crore at an outlay of Rs.209.08 Crore sanctioned under RIDF- XXVII scheme for the year 2021 – 2022 and also accorded permission to Commissioner of Town Panchayats for utilizing the Additional Expenditure of Rs.8.38 Crore from the General Fund of Town Panchayats.

4. In the letter fourth read above, the commissioner of Town Panchayats has requested the Government to release the balance amount of Rs.143.88 Crore to Improve 192 road works to a length of 292.659 KM in 147 Town Panchayats in 31 districts at a cost of Rs.181.30 Crore and construction of 11 Bridge works in 7 Town Panchayats in 6 districts at a cost of Rs.19.40 Crore at an outlay of Rs.200.70 Crore sanctioned under RIDF-XXVII scheme for the year 2021 – 2022.

5. The Government, after careful consideration, accept the proposal of the commissioner of Town Panchayats and accord sanction to release a sum of Rs.143,88,19,000/- (Rupees One Hundred and Fourty Three Crore Eighty Eight lakh and Nineteen thousand only) towards Strengthening of 192 road Works in 147 Town Panchayats in 31 Districts and Construction of 11 Bridge works in 7 Town Panchayats in 6 districts under NABARD RIDF-XXVII Scheme for the year 2021-22.

6. The amount sanctioned in para 5 above shall be debited under the following head of Account:-
