The Mission Director, Smart Cities Mission and Additional Chief Secretary/Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has further stated that, based on the Government of India releases, fund to be released by Government of Tamil Nadu for Thoothukudi and Vellore Smart Cities is **Rs.173.25 crore** [Government of India share Rs.85.375 crore (project fund Rs.81.75 crore and Administrative and Office Expenses fund Rs.4.375 crore) and Government of Tamil Nadu share Rs.87.50 crore]. The Additional Chief Secretary/Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested the Government to issue necessary orders for release of an amount of **Rs.173.25 crore** for implementation of projects in Thoothukudi and Vellore Smart Cities.

5. The Government after careful examination has decided to release a sum of **Rs.173,25,00,000/-** (Rupees One hundred seventy three crore and twenty five lakh only) [Government of India share Rs.85.75 crore and Government of Tamil Nadu share Rs.87.50 crore] for implementation of projects in Thoothukudi and Vellore Smart Cities for the Financial Year 2022-23.

He is also directed to include this item of expenditure while sending the budget proposal for Revised Estimates / Final Modified Appropriation 2022-23 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2022-23 to Government in Finance (BG-I/MAWS) Department at an appropriate time without fail.
