AMENDMENTS.

In the said Rules,

(1) in rule 2, in clause (1), for the expression "and the Thoothukudi City Municipal Corporation Act, 2008 (Tamil Nadu Act 27 of 2008) in respect of Thoothukudi City Municipal Corporation", the following expression shall substituted, namely:—

City Municipal Corporation, the Sivakasi City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 2 of 2021) in respect of Sivakasi City Municipal Corporation, the Kancheepuram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 3 of 2021) in respect of Kancheepuram City Municipal Corporation, the Karur City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 4 of 2021) in respect of Karur City Municipal Corporation, the Tambaram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 5 of 2021) in respect of Tambaram City Municipal Corporation ordinance, 2021 (Tamil Nadu Ordinance 7 of 2021) in respect of Kumbakonam City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 7 of 2021) in respect of Kumbakonam City Municipal Corporation";

- (2) in rule 3,-
 - (i) in sub-rule (1), the expression "by the Inspector of, in the case of" shall be omitted;
 - (ii) in the Explanation, the expression "or the Inspector of" shall be omitted;
- (3) in rule 5, to sub-rule (2), the following proviso shall be added, namely:—
 "Provided that, where after completion of one full term, no ordinary election is held to the
 offices of the Chairman of Town Panchayats and Municipalities and the Mayor of
 Corporations before expiry of the ten year period, the reservation to such offices shall
 be rotated for the next ordinary election in such Town Panchayats, Municipalities and
 Corporations.".
