ORDER:

In the Government order second read above, the Government have approved the guidelines for implementation of "Singara Chennai 2.0", with an allocation of Rs.500 crore in the budget for the financial year 2021-2022. The scheme is being implemented by the Greater Chennai Corporation and Chennai Metropolitan Water Supply and Sewerage Board from the financial year 2021-2022 onwards.

- **2.** Similarly, Administrative Sanction for the implementation of Atal Mission for Rejuvenation and Urban Transformation 2.0. in the State has been issued vide the Government Order third read above. Also, by the said Government order, the State High Powered Steering Committee (SHPSC) of Atal Mission for Rejuvenation and Urban Transformation 2.0 under the chairmanship of the Chief Secretary for approval of the Projects has been constituted.
- **3.** In the Government Order first read above, Administrative Sanction was accorded for Water Supply Scheme, having components of 5 towns, namely, Uthandi, Jalladampettai, Mathur, Madipakkam and Neelankarai, at a cost of Rs.184.11 crore, under the Atal Mission for Rejuvenation and Urban

Transformation. However, the Neelankarai Water Supply component under Atal Mission for Rejuvenation and Urban Transformation could not be taken up by the Chennai Metropolitan Water Supply and Sewerage Board due to non-availability of suitable land.

4. Now, the Project Sanctioning and Monitoring Committee of "Singara Chennai 2.0", at its 8th meeting held on 09.03.2022, inter-alia, has approved the Neelankarai Water supply project at a cost of Rs 6,667.11 lakh [Singara Chennai 2.0 Share: Rs.4,568.11 lakh] under "Singara Chennai 2.0" for the Financial Year 2021-22, as given in table below, subject to the conditions specified in the appraisal report:

The Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited in his proposal fourth read above has stated that, the Project Sanctioning and Monitoring Committee (PSMC) at its 8th meeting held on 09.03.2022, inter-alia, has also approved the above project of "improvement of Sewer Collection System along Anna Main Road from Ashok Nagar Sewage Pumping Station (SPS) up to Nesapakkam Sewage Pumping Station (SPS)" in Area X of Chennai Metropolitan Water Supply and Sewerage Board at an approved project cost of Rs.3,153.90 lakh, under "Singara Chennai 2.0" for the Financial Year 2021-22, as given in table below:

- 6. The Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation has stated that, as informed by Managing Director, Chennai Metropolitan Water Supply and Sewerage Board, the work of "Improvement of Sewer collection system along Anna Main Road from Ashok Nagar Sewage Pumping Station to Nesapakkam Sewage Pumping Station" is primarily envisaged to avoid transmission of sewage collected in Areas IX, X and XIII and transmitted through common gravity interceptor by diverting the sewage to nearest Sewage Pumping Station and convey the same upto Nesapakkam STP, by strengthening the existing Sewage Pumping Station at Ashok Nagar and K.K.Nagar 'B' Sewage Pumping Station and revamping the already abandoned SPS at Old Nesapakkam Sewage Pumping Station at MGR Nagar and K.K.Nagar 'A' Sewage Pumping Station at Alagirisamy salai for collection and final disposal. The Chennai Metropolitan Water Supply and Sewerage Board has also proposed to enlarge the existing sewer collection system from 250mm dia to 700mm dia, for a length of 3327 mtrs, using DWC and CI pipes.
- 7. The Chennai Metropolitan Water Supply and Sewerage Board has proposed to abandon the entire length of CCRCP gravity main in Anna main road from Ashok Nagar Sewage Pumping Station to Nesapakkam Terminal pumping station for a length of 3239 m, since carrying out the rectification and upgradation works are not found effective due to the pipe condition of the existing RCC gravity interceptor and the soil condition which takes more time for rectification due to higher depth, high water table and high velocity of sewage flow which again leads to further development of caving in this stretch. Further, frequent repair works that are being carried out along the above stretch which is a busy bus route road, apart from incurring huge expenditure, causes inconvenience to the general public. The project has been proposed based on the site condition and land availability adjacent to Anna main road and by incorporating existing / serviceable CI pumping mains.
- **8.** Further, the State High Powered Steering Committee under Atal Mission for Rejuvenation and Urban Transformation 2.0 at its 2nd meeting held on 8.3.2022, has approved the State Water Action Plan (SWAP) for Tranche-1 for the FY 2021-2022 which includes the above project under Atal Mission for Rejuvenation and Urban Transformation 2.0, by dovetailing with Singara Chennai 2.0.
- 9. In the above circumstances, the Additional Chief Secretary/ and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested Government to accord (a) Revised Administrative sanction for "Neelankarai water supply project" for Chennai City at a project cost of Rs.6,667.11 lakh with Singara Chennai 2.0 Share of Rs.4,568.11 lakh (b) Administrative sanction for implementation of the project of "improvement of Sewer Collection System along Anna Main Road from Ashok Nagar Sewage Pumping Station up to Nesapakkam Sewage Pumping Station" in Area X of Chennai Metropolitan Water Supply and Sewerage Board at a project cost of Rs.3,153.90 lakh under "Singara Chennai 2.0" for the Financial Year 2021-22, subject to the conditions specified in the apprisal report.

10. The Government after careful examination of the above proposal of the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited have decided to accept the same and accord Revised Administrative Sanction for "Neelankarai water supply project" for Chennai City under "Singara Chennai 2.0" at a project cost of Rs.6,667.11 lakh, with the following funding pattern, subject to the conditions specified in the appraisal report:
