ORDER:

In the Government Order first read above, administrative sanction was accorded for the improvement of 192 road works to a length of 292.659 Km in 147 Town Panchayats in 31 Districts at an estimated cost of Rs.181.30 Crore and Construction of 11 Bridge works in 7 Town Panchayats in 6 Districts at a cost of Rs.19.40 Crore at an total outlay of Rs.200.70 Crore under NABARD RIDF XXVII Scheme for the year 2021-22.

2. In the letter second read above, the commissioner of Town Panchayats has requested the Government to release a sum of Rs.200.70 Crore under NABARD RIDF-XXVII Scheme for the year 2021-22 Scheme so as to release the same to Town Panchayats early for execution of works.

3. The Government, after careful consideration, accept the proposal of the commissioner of Town Panchayats and to accord sanction and release a sum of Rs.56,81,81,000/- (Rupees Fifty Six Crore Eighty One Lakh and Eighty One Thousand only) under NABARD RIDF-XXVII Scheme for the year 2021-22.
