### **ORDER:**

The Ministry of Housing and Urban Affairs, Government of India has launched Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0) on 01.10.2021. The key components of the Mission are (a) Universal coverage of water supply; (b) Sewerage, Septage management and recycle / reuse of treated used water; (c) Rejuvenation of water bodies (including urban wet lands) and (d) Creation of green spaces.

2. Administrative sanction for implementation of Atal Mission for Rejuvenation and Urban Transformation 2.0 in the State has been accorded and the State High Powered Steering Committee (SHPSC) headed by the Chief Secretary to Government has been constituted for the approval of the Projects under the Mission, vide the Government Order first read above.

3. In the letter third read above, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that, the State High Powered Steering Committee (SHPSC) of Atal Mission for Rejuvenation and Urban Transformation 2.0 during its 5<sup>th</sup> meeting held on 28.11.2022 vide

the minutes second read above, has approved - among others - the following projects for Town Panchayats:

**I. Water Supply Projects for Town Panchayats (New Projects – Tranches I and II)**

Seven (7) water supply projects proposed by the Commissioner of Town Panchayats have been approved at an appraised project cost of Rs. 156.74 crore under Atal Mission for Rejuvenation and Urban Transformation 2.0 Tranches-I and II (Financial Year 2022-23) as below:

Various components of the proposed water supply projects include source creation and improvement; treatment; installation of pumping main; distribution system;

storage reservoir - construction of overhead tanks, sumps; installation of Supervisory Control and Data Acquisition (SCADA) system and effecting house service connections. The above projects are designed to cater 24 x 7 water supply system as per the functional outcomes indicated in the mission guidelines.

## II. Development of Green Space project for Polur Town Panchayat (New Project- Tranche-II)

"Development of green space" project in Polur Town Panchayat in Tiruvannamalai District has been approved at an appraised project cost of Rs.0.26 crore under Atal Mission for Rejuvenation and Urban Transformation 2.0 Tranche-II (Financial Year 2022-23) as below:

The proposed park project is to be developed as per the aspirations of the citizens which would help in improving the environmental, aesthetic and health needs of the urban dwellers and comprise of necessary facilities, including footpath, children play area, multipurpose play court, toilet, lighting and required greeneries etc.

## III. Rejuvenation of Water bodies' Projects for Town Panchayats (New Projects -Tranche -II)

Rejuvenation of water bodies' projects in three Town Panchayats have been approved at an appraised project cost of Rs.1.22 crore under Atal Mission for Rejuvenation and Urban Transformation 2.0 Tranche-II (Financial Year 2022-23) as given below:

The proposed water bodies' projects will not only improve water storage but will also help in flood control. The rejuvenation of water bodies will address the interference or damages caused to the water bodies due to various reasons. Rejuvenated water bodies will also act as recreational space for the citizens. Various components of the proposed 'Restoration of Water bodies' projects include desilting, greenery, foot path, seating, lighting, children play material, CCTV, security room and fencing etc.

4. Accordingly, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to issue necessary administrative orders for the above projects.

5. The Government after careful examination of the proposal of the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, have decided to accept the same and accordingly issue administrative sanction for implementation of water supply projects for seven Town Panchayats, Development of green space project in Polur Town Panchayat and Rejuvenation of water bodies' projects for three Town Panchayats at a total appraised project cost of Rs.158.22 crore (Rupees one hundred fifty eight crore and twenty two lakh only) under Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0) Tranche-I and Tranche-II for the Financial Years 2021-22 and 2022-23 as approved by State High Powered Steering Committee during its 5<sup>th</sup> meeting held on 28.11.2022, detailed at paragraph 3 above.
